

RESOLUTION NO. 2014-17

A RESOLUTION OF THE TOWN COUNCIL OF SILVER CITY, NEW MEXICO, AUTHORIZING THE SUBMISSION OF A NEW MEXICO COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM APPLICATION TO THE DEPARTMENT OF FINANCE AND ADMINISTRATION/LOCAL GOVERNMENT DIVISION; AND AUTHORIZING THE TOWN MANAGER AS THE TOWN OF SILVER CITY'S AUTHORIZED REPRESENTATIVE TO ACT IN ALL MATTERS PERTAINING TO THE TOWN OF SILVER CITY'S PARTICIPATION IN THE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM.

WHEREAS, the need exists within the Town of Silver City for neighborhood improvement projects in several low and moderate income neighborhoods, and the Town of Silver City desires to apply to the Housing and Urban Development's Community Development Block Grant Program to obtain funding for neighborhood improvement projects; and

WHEREAS, there have been four public meetings held to encourage public input and comment during the 2014 application process; and

WHEREAS, the Town Council finds that there is a significant need to undertake a Street and Drainage Improvement Project on Arizona, Chihuahua, Gila and Sonora Street in the Chihuahua Hill Neighborhood Area to provide adequate services to the community; and

WHEREAS, the Town Council determines that the Street and Drainage Improvement Project on Arizona, Chihuahua, Gila and Sonora Street meets the requirements of the Community Development Block Grant Program;

NOW THEREFORE, BE IT RESOLVED by the Council of the Town of Silver City, New Mexico, that

1. The Town of Silver City is hereby authorized to prepare and submit a Community Development Block Grant application to the New Mexico Department of Finance and Administration/Local Government Division for a Street and Drainage Improvement Project on Arizona, Chihuahua, Gila and Sonora Street; and
2. The Town Council directs and designates the Town Manager as the Town of Silver City's Authorized Representative to act in all matters in connection with this application and the Town of Silver City's participation in the New Mexico Community Development Block Grant Program; and
3. The application be for \$500,000.00 of grant funds to carry out a Street and Drainage Improvement Project on Arizona, Chihuahua, Gila and Sonora Street in the Chihuahua Hill Neighborhood Area; and
4. That it further be stated that the Town of Silver City is committing \$75,000.00 from its general fund as a cash contribution toward design and construction activities of this Street

and Drainage Improvement Project on Arizona, Chihuahua, Gila and Sonora Street in the Chihuahua Hill Neighborhood Area.
