

RESOLUTION NO. 2016-20

**PARTICIPATION IN LOCAL GOVERNMENT ROAD FUND PROGRAM
ADMINISTERED BY NEW MEXICO DEPARTMENT OF TRANSPORTATION**

WHEREAS, the Town Council of Silver City and the New Mexico Department of Transportation have determined that it is in the public interest to enter into a Cooperative Agreement with regard to a certain road project within the Town of Silver City; and

WHEREAS, the total cost of the project will be \$62,631.00 to be funded in proportional share by the parties hereto as follows:

- a. New Mexico Department of Transportation's share shall be 75% or \$46,973.00; and
- b. The Town of Silver City's proportional matching share shall be 25% or \$15,658.00; and
- c. The Town of Silver City shall pay all costs, which exceed the total amount of \$62,631.00;

NOW THEREFORE, BE IT RESOLVED by the Town Council of the Town of Silver City that:

1. The Town of Silver City shall and does hereby enter into a Cooperative Agreement Project Number **SP-1-17 (967)**, Control Number **HW2 L100269** with the New Mexico Department of Transportation for LGRF Project for year 2016/2017 with a project scope: **"Project development, construction and materials (purchasing through state pricing agreement) for a Chip Seal and Fog Seal – Blue Jay Lane – Raven Drive to Dead-end; Cardinal Lane – Raven Drive to Dead-end; Debby Drive – Blue Jay Lane to Dead-end; Fowler Avenue – 32nd Street to Dead-end; Fran Drive – 37th Street to 40th Street; Fran Place – Fran Drive to Cul-de-sac; Glenda Circle – Fowler Avenue to Cul-de-sac; Gold Street – 38th Street to Silver Street; Huff Street – 38th Street to Gold Street; Lisa Place – Silver Street to Cul-de-sac; Lori Place – Silver Street to Cul-de-sac; Omega – 40th Street to Cul-de-sac; Raven Drive – Fowler Avenue to Dead-end; Silver Street – 32nd Street to Dead-end; Sunset – Fowler Avenue to Dead-end; Tracy Circle – Silver Street to Silver Street; Tracy Place – Tracy Circle to Cul-de-sac; Valley Vista – 37th Street to 40th Street; Vicky Place – Fowler Avenue to Cul-de-sac; 36th Street – Swan Street to Tracy Circle; 37th Street – Silver Street to Valley Vista; 38th Street – Swan Street to Silver Street; 40th Street – Silver Street to Fowler Avenue; 41st Street – Swan Street to Silver Street."**
2. The referenced Cooperative Agreement has a priority standing.
3. The Cooperative Agreement terminates on December 31, 2017 and the Town of Silver City incorporates all the agreements, covenants, and understandings between the parties hereto concerning the subject matter hereof, and all such covenants, agreements and understandings have been merged into the written agreement.
