PEDDLERS PERMIT APPLICATION

Definition: The word “peddler” shall mean any person, whether a resident or not, traveling from place to place, from house to house, or from street to street, for the purpose of selling or soliciting for sale, goods, wares, merchandise or services (except the sale of agricultural products produced or processed in this state or agricultural products cultivated by the seller himself), but shall not apply to solicitations or sales made by charitable, educational, or religious organizations which have their principal place of activity with the Town of Silver City.

IT IS UNLAWFUL FOR ANY PERSON TO ENGAGE IN BUSINESS AS A PEDDLER WITHIN THE TOWN OF SILVER CITY WITHOUT FIRST OBTAINING A PERMIT TO DO SO.

PERMITTEES ARE PRESUMED TO KNOW THE LAW REGARDING DOING BUSINESS IN THE TOWN OF SILVER CITY. (REFER TO MUNICIPAL CODE, SECTION 20-1 THROUGH 20-32 AND ORDINANCE 1096).

ANY PEDDLER SHALL WHO ENTERS UPON PREMISES OWNED, RENTED OR LEASED BY ANOTHER AND REFUSES TO LEAVE SUCH PREMISES AFTER HAVING BEEN NOTIFIED BY THE OCCUPANT SHALL BE DEEMED GUILTY OF A MISDEMEANOR. NO PEDDLER SHALL ENTER UPON PROPERTY WHICH IS POSTED “NO SOLICITATIONS ALLOWED,” OR OTHER WORDS TO SUCH EFFECT. UNLESS INVITED, YOU ARE NOT TO ENTER UPON NON-BUSINESS PRIVATE PROPERTY. (REFER TO SECTION 10-37 OF THE TOWN OF SILVER CITY MUNICIPAL CODE)
