

**NOTICE OF INTENT
TO ADOPT AN ORDINANCE AMENDING CHAPTER 10, ARTICLE II (BUSINESS
REGISTRATION) SECTION 10-23 OF THE MUNICIPAL CODE OF
THE TOWN OF SILVER CITY**

The Council of the Town of Silver City, Grant County, New Mexico hereby gives notice of its intention to adopt an amendment to the Town of Silver City Code of Ordinances. This notice is given the title as follows:

ORDINANCE NO. 1262

**AN ORDINANCE AMENDING CHAPTER 10, ARTICLE II (BUSINESS
REGISTRATION) SECTION 10-23 OF THE MUNICIPAL CODE OF
THE TOWN OF SILVER CITY**

WHEREAS, the Town Council passed and adopted Ordinance Number 1259 which amended the Town's Municipal Code with regard to business licensing and registration; and

WHEREAS, the staff of the Town's Fire Department has prepared a schedule of fees which include particular fees for Fire Department inspections of commercial property; and

WHEREAS, the Town Council of the Town of Silver City finds that modification of Chapter 10, Section 10-23 (Fees) is necessary to properly reflect the current fees charged by the Town's Fire Department for commercial inspections; and

WHEREAS, the Town Council finds that such modification to the existing provision regulating the inspection fees relating to commercial properties within the Town is necessary for the health, safety and welfare of the Town and its inhabitants;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF SILVER CTY, GRANT COUNTY, NEW MEXICO THAT :

Existing Section 10-23 (c) is deleted in its entirety and replaced with:

Section 10-23

(c) In addition to any license fees mentioned herein this section, the fee(s) for any inspections provided for by this chapter shall be in accordance with the fee schedule adopted and published by the Town's Fire Chief and in effect at the time of inspection.
