

**RESOLUTION NO. 2018-31**

**A RESOLUTION DECLARING THE ELIGIBILITY AND INTENT OF THE TOWN OF SILVER CITY IN GRANT COUNTY, NEW MEXICO TO SUBMIT AN APPLICATION TO THE FEDERAL HIGHWAY ADMINISTRATION (FHWA) FOR FEDERAL FISCAL YEAR 2020/2021 FEDERAL LANDS ACCESS PROGRAM (FLAP) FUNDS.**

**WHEREAS**, the Town of Silver City has the legal authority to apply for, receive and administer federal funds; and

**WHEREAS**, the Town of Silver City is submitting a joint application with the County of Grant for Federal Fiscal Year 2020/2021 (FFY20/21) Federal Highway Administration FLAP funds, as set forth by the Federal legislation, Fixing America's Surface Transportation (FAST) Act; and

**WHEREAS**, the Little Walnut Road/Bicycle/Hiking Path Project named in the FLAP application are eligible project(s) under Federal Highway Administration Federal Lands Access Program; and

**WHEREAS**, the Town of Silver City assures and certifies that it will comply with the regulations, policies, guidelines, and match requirements and any requirements with respect to the acceptance and use of Federal Lands Access Program (FLAP) Funding; and

**WHEREAS**, the Town of Silver City agrees to pay any costs that exceed the project amount if the application is selected for funding; and

**WHEREAS**, the Town of Silver City agrees to maintain all project(s) constructed with FLAP funding for the useable life of the project(s);

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the Town of Silver City, that it endorses and supports an application for FY 2020/2021 Federal Lands Access Program (FLAP) Funding; and

The Town Council directs the Town Manager, Alex C. Brown, to submit a joint application with the County of Grant for FFY 2020/2021 Federal Lands Access Program (FLAP) funds from the Federal Highway Administration (FHWA) on behalf of the Town of Silver City for a Street and Drainage Improvement Project on Little Walnut Road from north of Chavez Lane to the City Limits. The Town Manager is designated to act in all matters in connection with this application, and to do all acts necessary to carry out the intent of the Resolution.
