**PARTICIPATION IN LOCAL GOVERNMENT ROAD FUND PROGRAM ADMINISTERED
BY NEW MEXICO DEPARTMENT OF TRANSPORTATION**

WHEREAS, the Town Council of Silver City and the New Mexico Department of Transportation have determined that it is in the public interest to enter into a Cooperative Agreement with regards to a certain road project within the Town of Silver City; and

WHEREAS, the total cost of the project will be \$123,486.00 to be funded in proportional share by the parties hereto as follows:

- a. New Mexico Department of Transportation's share shall be 75% or \$92,615.00; and
- b. The Town of Silver City's proportional matching share shall be 25% or \$30,871.00;
and
- c. The Town of Silver City shall pay all costs, which exceed the total amount of \$123,486.00;

NOW THEREFORE, BE IT RESOLVED by the Town Council of the Town of Silver City that:

1. The Town of Silver City shall, and does hereby enter into a Cooperative Agreement, Control Number **HW2 L100564** with the New Mexico Department of Transportation for a LGRF Project for fiscal year 2023/2024 with a project scope: **Chip seal and fog seal various Town streets: (1)Ben Lily Drive** – Little Walnut Road to Hugh McKeen Drive, **(2)Cain Drive** – Little Walnut Road to Swan Street, **(3)Chavez Lane** – Little Walnut Road to Dead End, **(4)Christian Flury Drive** – Little Walnut Road to Jack Frost Drive, **(5)Hugh McKeen Drive** – Vic Culberson Drive to Langstroth Drive, **(6)Indiana Street** – Little Walnut Road to Dead End, **(7)Jack Frost Drive** – Little Walnut Road to Christian Flury Drive, **(8)Langstroth Drive** – Little Walnut Road to Dead End, **(9)Michigan Street** – Little Walnut Road to Dead End, **(10)Ohio Street** – Little Walnut Road to Indiana Street, **(11)Pearce Road** – Langstroth Drive to Dead End, **(12)Pitchfork Ranch Road** – Pearce Road to Dead End, **(13)Tom Lyons Drive** – Vic Culberson Drive to Dead End, **(14)Trail Ridge Road** – Little Walnut Road to Cain Drive and **(15)Vic Culberson Drive** – Christian Flury Drive to Langstroth Drive; within the control of the Town of Silver City in Grant County, New Mexico.
2. The referenced Cooperative Agreement project is adopted and has priority standing.
3. The Cooperative Agreement terminates on December 31, 2024 and the Town of Silver City incorporates all the agreements, covenants, and understandings between the parties hereto concerning the subject matter hereof, and all such covenants, agreements and understandings have been merged into the written agreement.
